- **REFUND POLICY**

*What's your refund policy when it comes to COVID-19?*

For all program cancellations, refunds will be issued with a minimal \$10.00 fee to cover registration expenses until **June 26, 2020**. After this date, the maximum refund available is 50% of final payment.

- **TRANSPORTATION**

*Do you provide transportation?*

Parents/Guardians are responsible for transportation during this time. Sadly we are unable to provide transportation due to health and safety reasons for our DCSD buses.

To limit material contact, **WE WILL NOT BE KEEPING ANY LOST AND FOUND AFTER CAMP**. We will provide several opportunities for campers to view Lost and Found during their camp session to claim personal belongings.

- **WHAT ARE YOU DOING TO KEEP KIDS SAFE?**

We will continue to provide updates as they become available.

**Health Checks and Screening:** We want to go above and beyond protecting our community.

*Arrival Health Screening/Intake Health Screenings:* Camper Drop-off and pick-up times will be staggered amongst families: Families last names (A-M, arrival 8:00-8:15am, departure 4:30-4:45pm), last names (N-Z arrival 8:15-8:30am, departure 4:45-5:00pm). Only ONE family member may be present during drop-off and pick-up. Upon arrival individuals will be asked to remain in their car at the gate for health questionnaire screening. A temperature check and health screening will be collected from all individuals every morning or upon arrival, whichever comes first.

*Visitors:* Non-essential visitors will not be permitted entrance to the property while programs are active. Essential visitors will undergo a health screening check and observe strict social distancing guidelines. Masks are required for all guests.

**Group Size & Social Distancing:** Activity group sizes will be limited to 8-10 campers separated by age. Stone Canyon will have an upper camp (ages 9- 15) and lower camp (ages 5-8). One staff member to be assigned to each activity group and will be the primary Counselor for that group. Each activity group will have a substitute Counselor assigned to their group. The substitute will provide relief to the primary Counselor throughout the program. There will be no inter-changing of staff members for assigned activity groups within a day.

**Food Service:** Activity groups will be assigned a location outdoors to eat lunch each day. In the event of inclement weather activity groups will be relocated to separate areas indoors. Campers and staff will remain 6FT apart while eating. Prepackaged lunches will be served “to-go” and campers will transport their meals to their assigned location. There will be no sharing of food between campers and food brought from home will not be permitted at this time. Food service will be provided in alignment with EH&E guidelines.

**Cleaning and Sanitizing:** EAP approved cleaning solutions will be utilized in our cleaning and sanitizing procedures.

*Surfaces and equipment:* materials and gear will be sanitized before and after each use. Whenever possible gear will be assigned to a camper for the entire program. If equipment is used by multiple campers at once it will be disinfected at the end of the activity and all campers will wash their hands when the activity has ended.

*Common spaces:* will be cleaned and disinfected between uses at the end each day.

*Equipment used indoors and outdoors:* will be sanitized after each group use, and all high-touch areas will be disinfected at start and end of the day and, when possible, throughout the day.

**Health and Safety Precautions:** Face covering use will be required for all individuals on-site at camp. Social distancing of 6ft between individuals will be enforced. All campers and staff are required to thoroughly wash their hands with soap and water for 20-seconds but not limited to the following: Upon the start of each day, before and after any meal, after sneezing, after using the restroom, at the end of the camp day, upon entering an indoor space, after touching frequently touched surfaces, and after using common items such as sports equipment. Every two-hour's administration will provide Health & Safety Precaution checks and support activity group staff to enforce regulation requirements.

### **Sick Protocol**

If a camper or staff member becomes ill during programming, immediate isolation and quarantine plan will go into effect. The TCHD will be notified and cooperate under their guidelines. Symptoms will be monitored and documented and appropriate transportation will be arranged. Staff and campers should not return to camp, and should notify camp officials if they become sick with COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with symptoms or a confirmed or suspected case. Per Colorado state guidelines it is highly recommended to get tested for COVID-19 immediately. Campers and staff will not be permitted to return until symptom free for 24-hours.

### **COVID-19**

If there is a suspected case of COVID- 19 among campers or camp staff, Stone Canyon will immediately notify and cooperate with TCHD. Immediate isolation and quarantine will occur in the manor pre-defined in writing in the camp's communicable disease plan until appropriate return home transportation can be arranged. If clinical evaluation is needed, we will make arrangements to do so in-person or via telehealth.

If there is a confirmed case of COVID-19, Stone Canyon Outdoor EdVentures will close for a minimum of 24 hours or as directed by Stone Canyon's governing agencies.
